

## GOVERNMENT OF ZAMBIA

STATUTORY INSTRUMENT NO. 46 OF 2003

**The Zambia Wildlife Act**  
(Act No. 12 of 1998)**The Zambia Wildlife (Licences and Fees) Regulations, 2003**

IN EXERCISE of the powers contained in sections *thirty-four* and *one hundred and forty-four* of the Zambia Wildlife Act, the following Regulations are hereby made:

| <p>1. These Regulations may be cited as the Zambia Wildlife (Licences and Fees) Regulations, 2003.</p> <p>2. (1) An application for a non-resident hunting licence shall be made in Form ZAWA 1 as set out in the First Schedule.</p> <p>(2) The licensee shall pay the fee in respect of a non-resident hunting licence, as specified in the Second Schedule.</p> <p>(3) The non-resident hunting licence shall be in Form ZAWA 2 as set out in the First Schedule.</p> <p>(4) A non-resident hunting licence shall—</p> <p>(a) be issued to a client of a licensed hunting outfitter ; and</p> <p>(b) authorise the licensee to hunt the animals specified in the licence and in the numbers stated in the licence and shall be subject to the conditions specified in the licence.</p> <p>(5) A holder of a non resident hunting licence shall at the end of the hunting season submit to the Director-General a non-resident hunting licence order in Form ZAWA 3 set out in the First Schedule.</p> <p>3. (1) An application for a resident hunting licence shall be made in Form ZAWA 4 as set out in the First Schedule;</p> <p>(2) For purposes of this regulation a resident hunting licence may be issued—</p> <p>(a) by the national office in Form ZAWA 5 set out in the First Schedule; or</p> <p>(b) by a designated District office, in Form ZAWA 6 set out in the First Schedule;</p> <p>(3) A resident hunting licence issued under paragraph (b) of sub regulation (2) shall be valid only for the District in respect of which it is issued.</p> | <p>Title</p> <p>Non-resident hunting licence</p> <p>Resident hunting licence</p> |

(4) The licensee shall pay the fee in respect of a resident hunting licence as specified in the Second Schedule.

(5) A resident hunting licence shall authorise the licensee to hunt the game and protected animals specified in the licence and shall be subject to the terms and conditions set out in the licence.

(6) A holder of a resident hunting licence shall, in accordance with section *sixty-one* of the Act, keep, in Form ZAWA 7 set out in the First Schedule, a record of all animals hunted by such licensee during the validity of the licence.

Bird licence 4. (1) An application for a bird licence shall be made in Form ZAWA 8 as set out in the First Schedule.

(2) The licensee shall, in respect of a bird licence, pay the prescribed fee specified in the Second Schedule.

(3) A bird licence shall be in Form ZAWA 9 as set out in the First Schedule.

(4) A bird licence shall be subject to the conditions stated in the licence and shall authorise the licensee to hunt the birds specified in the licence, in any area in Zambia, other than a National Park, bird or wildlife sanctuary, and in the number specified in that licence.

Special licence 5. (1) An application for a special licence shall be in Form ZAWA 10 as set out in the First Schedule.

(2) The licensee shall, in respect of a special licence, pay the prescribed fee specified in the Second Schedule.

(3) The special licence shall be in Form ZAWA 11 as set out in the First Schedule.

(4) A special licence shall authorise the licensee—

(a) for purposes of scientific research or for the collection of specimens for zoological gardens, museums or education to hunt such game animal or protected animal as may be specified in the licence;

(b) to hunt in any stated National Park or Game Management Area such game animal or protected animal as may be specified in the licence;

(c) to rear any wild animal and for such purposes to capture for rearing or hunt in any stated area or part of the Republic such game animal or protected animal or protected animal as may be specified.

(5) The licensee shall keep in form ZAWA 7 set out in First Schedule a record of all animals captured, killed or wounded by the licensee during the validity of the licence.

6. (1) An application for a professional hunter's licence shall be made in Form ZAWA 12 as set out in the First Schedule. Professional hunter's licence
- (2) A professional hunter's licence shall be in form ZAWA 13 as set out in the first Schedule.
- (3) The licensee under this Regulation shall be subject to the terms and conditions specified in the licence, and shall, in respect of the licence, pay the fee specified in the Second Schedule.
- (4) A professional hunter's licence shall authorise the licensee to carry on business as a professional hunter, and while accompanied by a *bona fide* client, to hunt, such animals as are specified in the licence issued to such *bona fide* client in the numbers so prescribed in accordance with the terms and conditions set out in the licence.
- (5) Every licensee under a professional hunter's licence shall, in accordance with paragraphs (c) of section *sixty-two*, keep in Form ZAWA 14 set out in the First Schedule, on a daily basis, a record of—
- (a) each licence issued to each client in respect of which the licensee accepted engagement by such client as a professional hunter; and
  - (b) the game animals or protected animal, other than birds, hunted by, or on behalf of, such client under the licence.
7. (1) An application for an apprentice professional hunter's licence shall be made in Form ZAWA 15 as set out in the First Schedule. Apprentice professional hunter's licence
- (2) An apprentice professional hunter's licence shall be in Form ZAWA 16 as set out in the First Schedule and shall be subject to the conditions stated in the licence.
- (3) The licensee shall in respect of the licence pay the fee specified in the Second Schedule.
- (4) An Apprentice Professional Hunter's Licence shall—
- (a) be subject to the terms and conditions set out in the licence; and
  - (b) shall authorise the licensee to hunt the game and protected animals specified in the licence, under the supervision and subject to the instructions of a licensee under a Professional Guide's licence, in the areas of a Province, other than a National Park, bird or wildlife sanctuary, specified in the licence.
8. (1) An application for a professional guide's licence shall be made in Form ZAWA 17 set out in the First Schedule. Professional guide's licence
- (2) A professional guides licence shall be in form ZAWA 18 set out in the First Schedule.

(3) The licensee shall, in respect of the licence, be subject to the conditions specified in the licence and shall pay the fee specified in the Second Schedule.

(4) A professional Guide's Licence shall authorise a licensee to conduct, or to offer to conduct for reward, photographic or viewing safari in accordance with such terms and conditions as may be specified in the licence.

9. (1) Any person who ordinarily resides in Zambia may apply for an apprentice professional guide's licence and application shall be made in Form ZAWA 19 as set out in the First Schedule.

(2) The applicant shall, in respect of the apprentice professional guide's licence, pay the fee specified in the Second Schedule.

(3) An apprentice professional guide's licence shall be in Form ZAWA 20, as set out in the First Schedule and shall be subject to the conditions specified in the licence.

(4) The licence shall authorise the licensee to carry on business as an apprentice professional guide under the supervision, and subject to the instructions, of a licensee issued with a valid professional guide's licence while accompanied by the client in respect of whom the licensee is engaged, the conduct for reward, subject to the terms and conditions of the licence, photographic or viewing safari.

(5) A licensee shall not take any client out for game drives and walks unless accompanied by a licensee issued with a valid professional safari guide's licence.

10. (1) A person holding a valid tourism enterprise licence issued under the Tourism Act may apply for a photographic tour operator's licence which application shall be made in form ZAWA 21 as set out in the First Schedule.

(2) The applicant shall pay the fee specified in the Second Schedule.

(3) A photographic tour operator's licence shall be in Form ZAWA 22, set out in the First Schedule and shall be subject to the conditions specified in the licence.

(4) The licence shall authorise the licensee to conduct the business of a photographic tour operator subject to the terms and conditions specified in the licence.

11. (1) Any person may apply for a hunting outfitter's licence in Form ZAWA 23, set out in the First Schedule if the person—

- (a) holds a valid tourism enterprise licence issued under the Tourism Act;
- (b) ordinarily resides in Zambia; and
- (c) holds a hunting concession over a Game Management Area or part thereof.

(2) The applicant shall pay the fee specified in the Second Schedule,

(3) A hunting outfitter's licence shall authorise the licensee to conduct hunting operations in a Game Management Area or a hunting block subject to the terms and conditions of the licence.

(4) The hunting outfitter's licence shall be in Form ZAWA 24 set out in the First Schedule.

12. (1) Any person may apply for a restricted professional hunter's licence in Form ZAWA 25, as set out in the First Schedule.

(2) The applicant shall pay the fee specified in the Second Schedule.

(3) A restricted professional hunter's licence shall be in Form ZAWA 26, as set out in the First Schedule.

(4) The licence shall authorise the licensee to carry on business as a professional hunter in respect of non-dangerous animals subject to the terms and conditions as specified in the licence.

13. (1) Any person may apply for a commercial photographic licence in Form ZAWA 27, as set out in the First Schedule.

(2) The applicant shall pay the appropriate fee prescribed in the Second Schedule.

(3) A commercial photographic licence shall be in Form ZAWA 28, as set out in the First Schedule.

(4) The licensee shall, subject to the other provisions of the Act and to the terms and conditions stated in the licence, authorise the licensee to—

- (a) make paintings; or
- (b) take films or video;

in a national park, for commercial purposes.

14. A licence issued under the Act shall not be transferable.

15. (1) The Director General may at any time—

- (a) grant;
- (b) refuse to grant;
- (c) suspend;
- (d) revoke; or
- (e) cancel;

any licence under these regulations and shall upon so doing notify the applicant, in the appropriate form, as the case may be.

(2) A notice of refusal to grant a licence shall be in Form ZAWA 29, as set out in the First Schedule.

(3) A notice to revoke a licence shall be in Form ZAWA 30, as set out in the First Schedule.

(4) A notice to suspend or cancel a licence shall be in Form ZAWA 31, as set out in the First Schedule.

(5) Where a licence is suspended—

(a) the period of suspension shall be endorsed on the licence by the Director General;

(b) the licence shall be of no legal effect; and

(c) the licence shall be surrendered to the Director-General.

Certificate of ownership of trophies

16. (1) Any person who is in lawful possession of any trophy may apply to the Director General, for a certificate of ownership of the trophy to that person.

(2) The applicant shall pay the appropriate fee prescribed in the Second Schedule.

(3) The Director-General may upon being satisfied that a person is in lawful custody of any trophy, issue a certificate of ownership of that trophy to that person.

(4) A certificate of ownership shall be in Form ZAWA 32, as set out in the First Schedule.

(5) The Director-General may, upon satisfaction that a certificate was issued through error, fraud or misrepresentation of any person, revoke the certificate.

(6) The person to whom a certificate is issued shall, when the certificate is revoked, return the certificate to the Director-General, for cancellation.

(7) A notice of revocation shall be in Form ZAWA 33, as set out in the First Schedule.

Certificate of ownership of game animals or protected animal

17. (1) Any person who is in lawful possession of any game animal or protected animal may apply to the Director-General for a certificate of ownership of such game animal or protected animal.

(2) The applicant shall pay the appropriate fee as set out in the Second Schedule.

(3) The Director-General may upon being satisfied that a person is a lawful owner of any game animal or protected animal issue a certificate of ownership of that game animal or protected animal to that person.

(4) A certificate of ownership of game animal or protected animal shall be in Form ZAWA 34, as set out in the First Schedule.

(5) The Director-General may, upon satisfaction that a certificate was issued through error, fraud or misrepresentation of any person revoke the certificate.

(6) The person to whom a certificate is issued shall, when the certificate is revoked, return the certificate to the Director-General, for cancellation.

(7) A notice of revocation shall be in Form ZAWA 35, as set out in the First Schedule.

18. (1) Any person who wished to import any wild animal or the meat of any wild animal or any trophy, other than ivory or rhinoceros, horn, may apply to the Director for a permit to import such wild animal, meat or trophy.

Permit to import wild animals, meat or trophies

(2) The applicant shall pay the appropriate fee set out in the Second Schedule.

(3) The permit shall be in Form ZAWA 36 as set out in the First Schedule, and shall be valid for the period specified in the permit and shall be subject to the conditions specified in the permit.

(4) The permit issued under this regulation shall not be a substitute to any permit or authority to import any wild animal or meat or may trophy required by or under any written law nor shall the permit be deemed to relieve any person from any restriction on or prohibition of the import of any wild animal, meat or trophy imposed by or under the Act or any other written law.

19. (1) Any person who wishes to import any ivory or rhinoceros horn may apply to the Director-General for a permit to import such ivory or rhinoceros horn.

Permit to import ivory or rhinoceros horn

(2) The applicant shall pay the appropriate fee set out in the Second Schedule.

(3) The Director-General may, with the approval of the Authority, issue to the applicant a permit to import ivory or rhinoceros horn in Form ZAWA 37 set out in the First Schedule.

(4) The permit shall—

(a) specify the period of validity; and

(b) state the terms and conditions imposed on the permit holder by the Authority.

(5) The permit issued under this regulation shall not be in substitute to any permit or authority to import any ivory or rhinoceros horn required by or under any written law nor shall any restriction on or prohibition of the import of any ivory or rhinoceros horn imposed by or under the Act or any other written law.

20. (1) Any person may apply to the Director General for a trophy dealer's permit in Form ZAWA 38, as set out in the First Schedule.

Trophy dealer's permit

(2) The applicant shall pay the appropriate fee, as set out in the Second Schedule.

(3) A trophy dealer's permit shall be in Form ZAWA 39, as set out in the Fifth Schedule.

- (4) The permit shall—
- (a) state the period of validity;
  - (b) state the terms and conditions applicable to the holder of the permit; and
  - (c) authorise the holder of the permit to buy, sell, deal in, process or manufacture articles from trophies by way of trade or business.
- (5) The Director General may—
- (a) impose any conditions the Director General considers appropriate; or
  - (b) limit the permit to, or exclude from the permit, any specific trophy or class or trophies.
- (6) The Director General may at any time—
- (a) grant;
  - (b) refuse to grant;
  - (c) suspend;
  - (d) revoke; or
  - (e) cancel

any trophy dealer's permit and shall upon so doing notify the applicant, as the case may be, in the appropriate Form.

(7) A notice of refusal to grant a trophy dealer's permit shall be in Form ZAWA 40, as set out in the First Schedule.

(8) A notice to suspend, revoke or cancel a trophy dealer's permit shall be in Form ZAWA 41, as set out in the First Schedule.

21. (1) Any person who wishes to export any ivory, rhinoceros horn or nay game protected animal may apply to the Director General for a permit to export such ivory, rhinoceros horn or game protected animal.

(2) The applicant shall pay the appropriate fee set out in the Second Schedule.

(3) The Authority may, with the approval of the Minister, issue to the applicant a permit to export ivory or rhinoceros horn or any game protected animal in Form ZAWA 42 set out in the First Schedule.

- (4) The permit shall—
- (a) specify the period of validity; and
  - (b) State the terms and conditions imposed on the permit holder by the Authority.

(5) The permit issued under this regulation shall not be a substitution to any permit or authority to export any ivory or rhinoceros horn required by or under any written law nor shall any restriction on or prohibition of the export of any ivory or rhinoceros horn imposed by or under the Act or any other written law.



22. (1) Any person who wished to export any wild animal or the meat of any wild animal other than a protected animal, or any trophy, other than ivory of rhinoceros horn, may apply to the Director for a permit to import such wild animal, meat, or trophy.

Permit to export wild animals, meat or trophies

(2) The applicant shall pay the appropriate fee set out in the Second Schedule.

(3) The permit shall be Form ZAWA 43 as set out in the First Schedule, and shall be valid for the period specified in the permit and shall be subject to the conditions specified in the permit.

(4) The permit issued under this regulation shall not be a substitute to any permit or authority to export any wild animal or meat or any trophy required by or under any written law nor shall the permit be deemed to relieve any person from any restriction on or prohibition of the import of any wild animal, meat or trophy imposed by or under the Act or any other written law.

23. A permit to enter a national park shall be in Form ZAWA 44 set out in the First Schedule.

Permit to enter national Park

24. (1) An application for a permit to fish in a national park shall be made in writing to the Director-General.

Permit to fish in national Park

(2) The Director-General or any wild life police officer authorised in writing by the Director-General may issue a fishing permit where an application is made under sub regulation (1) and upon payment of the fee specified in the Second Schedule.

(3) The permit shall be in Form ZAWA 45 as set out in the First Schedule.

25. The National Parks and Wildlife (Licences and Fees) Regulations are hereby revoked.

CONDITIONS OF LICENCE

1. This licence expires on the 31st December in the year of issue.
2. This licence is valid only for the hunting block or open area stated therein unless endorsed otherwise by the Director General.
3. If the licensee wishes to hunt in another hunting block or open area, the licensee shall obtain a separate resident hunting licence for that hunting block or open area.
4. No hunting of female Hartebeest or female Warthog is permitted in Eastern Province from 1st August to 31st October and in all other provinces from 1st August, inclusive.
5. All game animals or protected animals killed, wounded or captured under this licence must within 24 hours be recorded in Form ZAWA 7 which accompanies this licence, and be made available for examination by an authorized officer of the Authority on demand.
6. The licensee shall retain a set of four hooves from every game animal or protected animal killed under this licence until the licence reaches the licensee's final destination in Zambia.
7. This licence is not transferable.
8. Holders of a Resident Hunting Licence are required to obtain a Certificate of Ownership within ninety (90) days of Hunting.
9. Holders of the Resident Hunting Licence are required to hand in the original licence to the Director General within ninety (90) days of the end of the hunting season or after 31st December each year.

NOTE:

Copies of this licence shall be distributed as follows:

- (a) White copy to be retained by the licensee

- (vii) Any Additional game animal of any one species, when available on non resident hunting quota, shall be sold at 50 per cent more than the prescribed licence.
- (viii) The purchase of any second or subsequent game animal of the same species, by any *bona fide* Client of a safari hunting outfitter, shall be restricted to the following species of game animals—
1. Baboon

  4. Impala

- Provided that the above restriction shall not apply to any *bona fide* client of a Safari hunting outfitter, who is not accompanied by any other person, other than that client's spouse or children, on that client's hunting safari.
- (ix) A leopard or a lion shall not be available for purchase under a Resident Hunting Licence for any Game Management Area, for which there is a valid non-resident hunting rights agreement.
- (x) In these notes "established resident" means any holder of a certificate attesting to a status as an established resident under section *thirty-three* of the Immigration and Deportation Act.

- (vi) Artisans and their employees shall avail themselves and their vessels for inspections to park staff while in National Park.
- (vii) Artisans and their employees are required to adhere to all park rules and regulations.
