Animal Health (Movement of Cattle and Pigs) Regulations, 1984

IT is hereby notified that the Minister of Agriculture has, in terms of section 5 of the Animal Health Act [Chapter 121], made the following regulations:—

#### Title

1. These regulations may be cited as the Animal Health (Movement of Cattle and Pigs) Regulations, 1984.

Sheep goet n.
Interpretation

2. In these regulations—

"alienated land" means-

- (a) land, the ownership of which is vested in any person other than the President; and
- (b) State land held in terms of an agreement of purchase or lease;

"cattle" means bovine animals;

'district administrator' in relation to any area of Communal land, means the district administrator of the district in which the particular area of Communal Land is situated;

"permit" means a permit issued by an authorized person for the purposes of these regulations;

"pig" means—

- (a) any pig, including any wild pig that is domesticated or is in captivity; and
- (b) any wart-hog that is domesticated or is in captivity;

"prescribed area" means—

- (a) in the case of alienated land-
  - (i) a single farm or plot; or
  - (ii) an area consisting of two or more farms or plots which are contiguous and are owned, occupied or leased by the same person;

(b) any area of commonage or land which—

(i) falls within the area under the jurisdiction of a municipal council or town board of a rural council; and

- (ii) is owned or leased by the State or any such council or in respect of which such a council has assumed control and management with an agreement with the owner of the land;
- (c) any area of Communal Land itemized and named in the Tribal Trust Land (Description of Area) Notice, 1980, published in Statutory Instrument 186 of 1980:
- (d) any area of forest land itemized and named in the Third Schedule to the Forest Act [Chapter 125];
- (e) any area of parks and wild life land itemized and named in the First, Second, Third, Fourth or Fifth Schedule to the Parks and Wild Life Act, 1975;
- (f) any area of State Land not referred to in paragraphs (a) to (e);

"private land" means land which is described in paragraph (a) or (b) of the definition of "prescribed area".

Prohibition of movement of cattle or pigs without permit

3. (1) Subject to subsection (2), no person shall move any cattle or pigs

- (a) into or from Zimbabwe; or
- (b) from any one prescribed area to or through any other prescribed area; or
- (c) where an authorized person has, by notice served in terms of section 31 or 32 of the Act prohibited such movement, for a distance of more than five kilometres within an area referred to in subparagraph (c) of the definition of "prescribed area";

otherwise than in accordance with the terms and conditions of a permit.

(2) Subsection (1) shall not apply in relation to cattle and pigs imported into Zimbabwe which are-

- (a) moved in accordance with the conditions of a permit issued in terms of the Animal Health (Import) Regulations, 1965, published in Rhodesia Government Notice 555 of 1965; or
- (b) in the course of transit, by air, through Zimbabwe and which are not off-loaded.

## Circumstances in which movement of cattle and pigs absolutely prohibited

- 4. Notwithstanding any other provisions of these regula-
  - (a) an authorized person shall not issue a permit for the movement of cattle or pigs; and
  - (b) no person to whom a permit has been issued shall move any cattle or pigs;

to, through, within or from any prescribed area where, owing to an outbreak or suspected outbreak of disease or infestation or suspected infestation with pests, such movement is prohibited—

- (i) by or in terms of any other regulations made in terms of the Act; or
- (ii) by an authorized person in terms of paragraph (b) of subsection (4) of section 21 of the Act.

#### Application for permit

- 5. A person who applies for a permit shall, in his application, furnish the following information—
  - (a) his name and address; and
    - (b) the number of cattle or pigs he wishes to move and, in the case of cattle, details as to the number of bulls, calves, cows and oxen; and Catagorye of the company.
    - (c) the name of the owner of the cattle or pigs; and
  - (d) the specified area from which and the specified area to which he wishes to move the cattle or pigs; and
  - (e) the period within which he wishes to move the cattle or pigs; and
  - (f) the route along which he wishes to move the cattle or pigs; and

(g) the method by which he wishes to move the cattle or

Proof of consent to movement of cattle or pigs

6. Before issuing a permit authorizing the movement of cattle or pigs--

(a) into any prescribed area; or

(b) through any prescribed area otherwise than by rail or along a public road;

an authorized person may require the applicant to produce written proof that—

(i) the owner of the private land has consented to such movement, where the prescribed area concerned is private land; or

(ii) the district administrator for the area has consented to such movement, where the prescribed area concerned is Communal Land or State Land used for resettlement purposes.

### Form of permits

7. A permit shall be in the form set out in the Schedule.

### Notification of movement of certain cattle

- 8. If a person has been issued a permit to move cattle, otherwise than on a vehicle or by rail, along a route which passes through any prescribed area, and-
  - (a) the number of cattle to be moved exceeds fifty head; or
  - (b) amongst the cattle is a bull which will not be led by an

### Permit to be carried by person moving cattle or pigs

9. The holder of a permit shall ensure that the drover, truck driver, train guard or other person in charge of cattle or pigs that are being moved carries the relevant permit with him while moving the cattle or pigs.

### Repeals

10. The Animal Health (Movement of Cattle) Regulations, 1971, published in Rhodesia Government Notice 868 of 1971, and the Animal Health (Movement of Cattle) (Amendment) Regulations, 1978 (No. 1), published in Rhodesia Government Notice 66 of 1978, are repealed.
